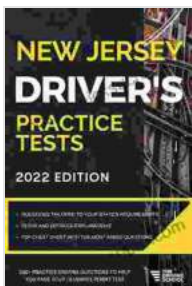

-  Blue: Describes services for motorists
-  Brown: Indicates historic, cultural, or recreation sites

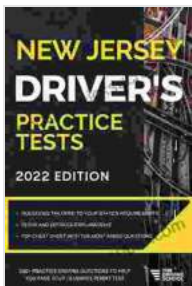

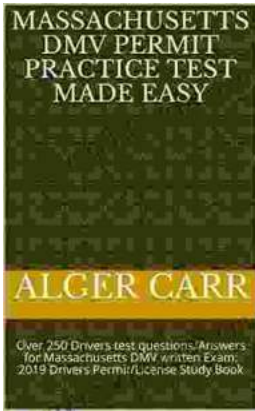

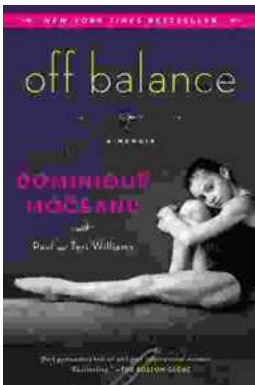
